The product complies with the basic requirements of PPER EU Regulation 2016/425 on personal protective equipment (PPE) and is based on harmonised European standards.

Personal protective equipment (PPE) complies with the general standard EN 13061:2009. Like any personal protective equipment (PPE), this product does not protect against all hazards. Please become acquainted with the specific risk assessment.

Composition:

Shin Guard Gain Control:

- protection layer 100% ABS
- absorbing layer 100% EVA.

Shin guard Gain Control Carbon:

- protection layer 100% carbon fiber
- absorbing layer 100% EVA

Shin Guard Personalised Gain Control:

- protection layer 100% ABS
- absorbing layer 100% EVA

Storage: The product should be stored in a dry and sun-free place. Do not store in rooms where the temperature drops below 10°C. Do not store in rooms where the air temperature is above 30°C.

Use: Do not use at temperatures below 0°C. Do not use above 35 °C. The product is not intended for professionals. Product for the hobby, occasional use. Product is designed for people under 140 cm height. Incorrect positioning of the protector may lead to bruising.

The product has no fastening straps and the correct positioning is done by the user who installs the protector under the sports sock for football or futsal.



How to install the protector correctly:

1. Wear a sports sock or a compression sleeve on your leg
2. Slide the shin guard under the sports sock or compression sleeve
3. Adjust the shin guard so that it is in the middle of the shinbone
4. If the sports sock or compression sleeve is unable to guarantee the correct placement of the product, wrap the protector and leg with a material wrap, tape or protective foam

Cleaning and maintenance: Remove all dirt with a damp cloth. The product must not be washed in the washing machine. Cleaning must be carried out in such a way that the original shape of the protector is not damaged.

No protector offers complete protection against injury. Risk of injury can only be minimised. Any destruction, alteration or improper use may jeopardise the level of protection. If the protector is damaged, it must be replaced immediately.
